As a condition of being permitted to travel with Psalm 82:3, Inc. and to participate in a mission trip to the Country of Haiti, the undersigned hereby:

1. Agrees to assume all normal and foreseeable risks associated with travel to, from and within Haiti (including but not limited to natural disasters, terrorism, political unrest, and contraction of illness) and releases Psalm 82:3, Inc. and its affiliates from any responsibility for such risk;
2. Acknowledges that the carriers, hotels and other supplies (the "suppliers") providing services in connection with the mission trip are independent contractors and are not agents, employees or representatives of, or joint ventures with, Psalm 82:3, Inc. or its affiliates and releases Psalm 82:3, Inc. and its affiliates from any responsibilities for the actions or omissions of such suppliers;
3. Agrees that Psalm 82:3, Inc. shall have no liability for any personal injury, property damage or other loss, accident, delay, inconvenience, or irregularity which may be caused by (a) any wrongful, negligent or unauthorized acts or omissions on the part of any of the suppliers or their agents, (b) any defect in or failure of any vehicle, equipment or instrument owned, operated or otherwise used by any supplier, or (c) any wrongful or negligent acts of omissions on the part of any other party not under the control of Psalm 82:3, Inc.;
4. Releases Psalm 82:3, Inc., its offices, directors, employees, agents and representatives from any claims whatsoever relating to the mission trip to Haiti;
5. Agrees not to sue or otherwise hold Psalm 82:3, Inc. responsible for any injury, damage, or loss resulting to the undersigned or the undersigned's property in connection with the undersigned's participation in the mission
6. Undersigned accepts full responsibility for luggage and other belongings brought on the mission trip
7. Agrees to submit any dispute, claim or cause of action arising out of the undersigned's participation in the mission trip to Haiti solely to a Christian arbitration panel, agreeing that lawsuits among and between Christians
8. Agrees to be responsible for any injuries, damages or losses caused by the undersigned while the undersigned is traveling with representatives of Psalm 82:3, Inc. or while the undersigned is in Haiti.
9. The undersigned acknowledges that Psalm 82:3, Inc. has recommended that the undersigned obtain physical examination and proper inoculations prior to going on the mission trip.
10. The undersigned acknowledges that he/she has been informed that United States citizens traveling outside of the United States are required to carry documentation of United States citizenship.
11. Consent for video and photography release. The undersigned gives permission to Psalm 82:3, Inc. to use photos taken during the mission trip for advertising and promotional purposes for works engaged in by Psalm 82:3, Inc. No compensation will be provided by Psalm 82:3, Inc. for the use of the images. Psalm 82:3, Inc. will not sell, trade, or barter with other organizations for the use of the images captured, and will only use the images for the promotion of work engaged directly by Psalm 82:3, Inc. Use of images taken by a participant of a mission trip may be used only for personal use. No images taken by a participant during the mission trip may be sold, traded, bartered, or given to another organization unaffiliated with Psalm 82:3, Inc. without prior written approval from Psalm 82:3, Inc.

12. Non-refundable deposits. The undersigned is aware that all deposits for trips are non-refundable. If the undersigned chooses to not participate in the mission trip after any deposits have been made to Psalm 82:3, Inc., the undersigned is aware they will not receive a refund. The undersigned has been informed that all deposits are non-refundable and will take no action against Psalm 82:3, Inc. to retrieve funds deposited for trip services not received that are outside of the control of Psalm 82:3, Inc. Such events that are beyond the control of Psalm 82:3, Inc. include, but are not limited to, Civil Unrest, War, Inclimate Weather, and Political Action.

13. Tax deductible contributions. The undersigned agrees that Psalm 82:3, Inc. is not responsible for the undersigned's, or contributors' to the undersigned's trip on their behalf, ability to claim funds paid for a mission trip as a tax deduction, and Psalm 82:3, Inc. makes no warrants or statements that the funds paid for a mission trip will be considered as a tax deduction. Psalm 82:3, Inc., advises participants, and their financial supports, to seek answers from a tax professional to determine the legality of claiming such contributions as a tax deduction.
